- **I.** Call to order with introductions Buyce called the meeting to order at 9:30 am.
- II. Pledge of Allegiance
- III. Roll Call conducted.
- **IV. Reading and approval of the June 6, 2023, meeting minutes** The minutes were provided in advance of the meeting.
- A motion was made by Bain, seconded by Stortecky to approve the June 6, 2023, meeting minutes. All voted in favor, motion carried.
- V. Treasurer's Report Remias reviewed the Treasurer's Report.

• A motion was made by Stortecky, seconded by Buyce to accept the Treasurer's report, and approve the bills to be paid. All voted in favor, motion carried.

VI. Executive Session to discuss lawsuits

- A motion made by Stortecky, seconded by Buyce to enter Executive Session, inviting Stewart, Remias and WhitKovits, to discuss lawsuits at 9:37 a.m. All in favor, motion carried.
- A motion made by Bain, seconded by Stortecky to exit Executive Session at 9:54 a.m. All in favor, motion carried.

The Board of Directors agreed that they will consult with County Attorney Chuck Getty before replying to emails regarding the website.

- **VII. Preliminary 2024 budget discussion** Stewart reported that the District is normally asked to submit the request for our county allocation in August.
 - A motion was made by Buyce, seconded by Rhodes to permit Stewart to request a 2% increase for the 2024 Hamilton County budget allocation. All voted in favor, motion carried.
- VIII. AutoCAD LT purchase Stewart reported that Croote uses this software to design projects and permits (ex. Higgins Bay Cemetery). He was using the free version, but the company discontinued it. He needs to access 20 years of files.
 - A motion was made by Stortecky, seconded by Buyce to approve the purchase of an Auto Cad 3-year subscription in the amount of \$1,455.00. All in favor, motion carried.
 - IX. Laptop purchase Stewart reported that Tim Ellifritz has been working on her desktop computer, and determined that it not capable of efficiently processing her workload. Programs are sluggish, documents take a long time to load and sometimes do not save, and the computer often freezes. She seeks support to purchase a laptop she can use at home, at the office, in the field, and at meetings.
 - A motion was made by Stortecky, seconded by Bain to approve the purchase of a Dell Technologies Latitude 5430 Rugged and docking station in the amount of \$3,884.52. All in favor, motion carried.
 - **X. Hydroseeding supplies purchase** Stewart reported that most of this expense will be reimbursed through our Upper Hudson Roadside Erosion Remediation Program grant.

- A motion was made by Rhodes, seconded by Buyce to approve the purchase of hydroseeding supplies in the amount of approximately \$16,000. All in favor, motion carried.
- **XI.** Caring Through Conservation Mini Grant application approval Stewart reported that 3 applications were received. She reviewed the applications per the ranking sheet. With the approval of these applications, \$4,642.67 will be expended of the \$10,000, with a balance of \$5,357.33.
 - A motion was made by Stortecky, seconded by Buyce to approve the following Caring Through Conservation Mini Grant applications: Indian Lake Theater's Monarch Report, \$1,150.00; Town of India Lake's Monarch and Milkweed Challenge, \$1,497.67, and the Town of Lake Pleasant's Community Garden Fencing, \$1,995.00. Buyce, Stortecky, Rhodes, and Hansen in favor; Bain abstained; motion carried.

XII. District Activities

- **a. Draft watershed health and farming justice legislation update** Nothing new to report.
- b. **Lake Monitoring Program** Stewart reported that she, WhitKovits, Croote, and Vander Pyl completed the June rotation. The boat is working well. She completed the Chain of Custody and delivered samples to Adirondack Watershed Institute.
- c. **Trail Stewardship Program** Croote reported that there is one more day of work on Buck Mountain and the District's portion of trail work will be complete. Lake Pleasant Highway Superintendent Randy Lavarnway has been contacted to coordinate work on the Sacandaga Pathways and Croote also contacted Town of Indian Lake Supervisor Brian Wells to coordinate projects. No other Town Supervisors or Highway Superintendents have contacted the District with trail or other projects. Adirondack Ecotrail work is ongoing. Vander Pyl has been working on a spur trail to the old growth pine trees. Manager Stewart noted Vander Pyl's strong work ethic and reiterated the positive asset he has been for the District.
- **d. Sediment and Erosion Control Program** Croote and Vander Pyl have completed several hydroseeding projects for the private sector.
- **e. Agricultural Environmental Management** WhitKovits reported that she has ArcGIS desktop and online so she can look up landowners on map and research farms. She is working with Warren and Oneida County SWCDs to go on site visits in early October.
- **f. Arbor Day Poetry Contest** Stewart reported that the CVW Long Lake Public Library hosted a celebration for the poetry contestants on June 28th. Poems were read and prizes were awarded.

- **g.** Water Testing Program Remias collected samples for the June 26th drop-off. We received 19 samples for delivery to the Mohawk Valley Water Authority for testing.
- h. Invasive Species Program Croote reported that the *Galerucella* beetles collected with Warren County SWCD for purple loosestrife biocontrol are healthy. He has picked a site on a large wetland in Long Lake to release the beetles. This site is close to the lake so the beetles, as a natural method of eradication, are best suited to this area. Vander Pyl has set the emerald ash borer trap and has been checking it. WhitKovits reported that she has ordered the injectors for the Japanese knotweed program for landowners. She has been working on the manual for the program and the county attorney is looking over the agreement between the landowners and the District.
- i. Conservation Education Program WhitKovits held a Pollinator event at the Long Lake Public Library on June 21st., She has Ecotrail tours scheduled with students from area schools and has begun work on Conservation Field Day which is scheduled for September 21st this year. Stewart presented Adirondack Waterfest at the Black River Watershed Conference on June 14th and the Warner Brook Streambank Stabilization project to NYS Soil and Water Conservation Committee on June 20th.

j. Watershed partnership update

- 1. **FLLOWPA** Stewart attended the Great Lakes Restoration Initiative funding meeting and submitted a stormwater related project for the Town of Inlet.
- 2. **Upper Hudson River Watershed Coalition** Stewart hosted the May 22nd picnic and meeting. Croote also attended.
- 3. **St. Lawrence River Watershed Project** Nothing new to report.
- 4. **Mohawk River Watershed Coalition** –Stewart hosted June 26th meeting and attended the Mohawk River Basin Steering Committee meeting on June 30th.
- 5. **Black River Watershed** Stewart attended and presented at June 14th conference.

k. Other

- 1. Website purchase \$2,500.
- A motion was made by Stortecky, seconded by Hanson to approve website purchase of \$2,500. All in favor, motion carried.

- **IX. Staff reports** Stewart disseminated and emailed copies of the staff reports. They are also appended to the minutes.
- X. District Conservationist's report Bielli reported that the Inflation Reduction Act has added increasing amounts of funding through the next four years. These funds enhance the Environmental Quality Incentive Program (EQIP) and Conservation Stewardship Program. These funds are for agricultural, climate smart, energy consumption, and forest operations (management, planting etc.) projects. There will be a local working group meeting at the Ballston Spa 4H building on Wednesday, July 12th from 1-3pm for any interested parties.
- XI. New York State Soil and Water Conservation Committee report appended to minutes.
- **XII.** Correspondence Thank you notes from NYACD for attending legislative day.
