## Board of Directors Meeting Minutes June 6, 2023

- I. Call to order with introductions Buyce called the meeting to order at 9:35 a.m.
- II. Pledge of Allegiance conducted.
- III. Roll Call conducted.
- IV. Reading and approval of the April 4 and May 2, 2023, meeting minutes The minutes were provided in advance of the meeting.
- A motion was made by Bain, seconded by Stortecky to approve the April 4 and May 2, 2023, meeting minutes. All voted in favor, motion carried.
- V. Treasurer's Report Remias reviewed the Treasurer's Report.

- A motion was made by Stortecky, seconded by Bain to accept the Treasurer's report, and approve the bills to be paid. All voted in favor, motion carried.
- VI. Japanese Knotweed Landowner Management Program Stewart reviewed WhitKovits' proposal to pilot the Japanese Knotweed Land Management Program.
  - A motion was made by Stortecky, seconded by Bain to pilot the Japanese Knotweed Land Management Program, and purchase 3 injector tools in the amount of \$671.98, with approximately \$30-\$40 shipping. All voted in favor, motion carried.
- VII. Caring Through Conservation Mini-Grant Program Stewart reviewed her proposal to pilot the Caring Through Conservation Mini-Grant Program.
- A motion made by Stortecky, seconded by Bain to pilot the Caring Through Conservation Mini-Grant Program in the amount of \$10,000 to fund a maximum of \$2,000 per project (5 projects total), with the Board of Directors approving applications. All voted in favor, motion carried.
- VIII. Adirondack Watershed Institute contract for laboratory services Stewart reviewed the contract. She mentioned that this is approximately a \$4,000 increase from last year's amount because we would like to include bottom water sampling of lakes with documented harmful algal blooms to augment our data analyses.
  - A motion made by Stortecky, seconded by Bain to permit District Manager Caitlin Stewart to sign the Adirondack Watershed Institute contract for laboratory services in the amount of \$21,800 for the 2023 lake monitoring season. All voted in favor, motion carried.
  - IX. District apparel Stewart mentioned that she would like to purchase shirts and hats for District staff and board members. Branded apparel will ensure our staff are recognized as professional, unified, and trustworthy while in the field and giving presentations. Safety green shirts are highly visible and enhance safety.

• A motion made by Stortecky, seconded by Buyce to approve the purchase of up to \$3,000 of apparel with Hamilton County SWCD branding for staff and board members from Clear Image. All voted in favor, motion carried.

#### X. District Activities

- a. Welcome Seasonal Technician Jacob Vander Pyl! Stewart reported that the District hired Vander Pyl to fill the County's Seasonal Technician vacancy for trail work and District projects. Vander Pyl began May 22, and has assisted with the Buck Mountain and Adirondack Eco Trails, the Hydroseeding Program, and rearing *Galerucella* beetles. Stewart encouraged town supervisors to send her projects for Vander Pyl to ensure the District fulfills the expectations and needs of the County's trail program. Vander Pyl is motivated and eager to assist and has been a wonderful addition to the team.
- b. **Draft watershed health and farming justice legislation update** Stewart reported that she contacted Megan Brosterman twice to inquire if any movement occurred, if the WHC is seeking sponsors for the proposed draft New York State Watershed Health Bill, and who the sponsors are, and has not received a reply.
- **c.** Adirondack Tree and Shrub Sale Stewart reported that this year's sale was a great success with excellent feedback from customers. Net income was \$2,231.63 and we sold 1,304 non-invasive trees and shrubs.
- d. Lake Monitoring Program Stewart reported that Croote has prepared the boat for the monitoring season. Croote, WhitKovits, and Vander Pyl met with Adirondack Watershed Institute staff to review calibration for the YSI Pro DSS meter. We are ready for our June rotation!
- e. Trail Stewardship Program Stewart reported work has been done on the Adirondack EcoTrail and Buck Mountain. The County DPW is working to complete the Buck Mountain parking lot, and Croote, WhitKovits, and Vander Pyl are implementing trail maintenance. Stewart encouraged supervisors and highway superintendents to contact Croote with projects for the seasonal technician to complete.
- **f. Sediment and Erosion Control Program** Croote and Vanderpyl have hydroseeded several private landowners and the hydroseeder is running well.
- **g. Agricultural Environmental Management** WhitKovits met with Cunningham to discuss our program and ideas.

- h. Hamilton County Envirothon Stewart reported that WitKovits did a beautiful job running this year's event. Record numbers attended. WhitKovits volunteered as Oral Presentation Judge at the NYS Envirothon and saw our Long Lake Team at the event.
- i. Invasive Species Awareness Week for New York state is June 5<sup>th</sup> 11<sup>th</sup>. The goal is to promote knowledge and understanding of invasive species and the harm they can cause. Whitkovits held a mosaic poster contest for invasive species and has done a Facebook campaign to spread awareness of invasive species. Additionally, our intern, Vander Pyl will be deploying our emerald ash borer within the next few days.
- j. Water Quality Coordinating Committee meeting Whitkovits organized this first meeting of the year and Board members Bain and Buyce attended and said they found it very informative. Bain thought the speakers were very good. Stewart stated that the Water Quality Coordinating Committee is linking experts with our lake associations and municipalities to provide them information about funding and resources and how to address water quality concerns. Whitkovits will compile attendees' concerns and revamp our strategy to prioritize and help find funding to assist with their projects.
- **k.** Arbor Day Poetry Contest Stewart reported that the gala will be held later in June at the Long Lake Public Library. There were 22 entries this year and there will be certificates, prizes and potluck for the senior citizens that participated.
- **l.** Water Testing Program Landowners dropped off 6 samples in May. The next drop off is June 26.
- **m.** Invasive species program We are once again rearing Galerucella beetles, that when mature feed off the invasive species, purple loosestrife. At maturity, they will be released to populate and feed on purple loosestrife in the area as a natural form of invasive species eradication.
- **n.** Conservation Education Program We have had numerous requests for presentations this summer. The Friends of Lake Algonquin, Maintain the Chain in Inlet and two summer youth programs have been scheduled for presentations.
- o. Watershed partnership update Stewart reported that all Watershed Coalitions are productive and seeking or implementing grants. The Black River Watershed Conference will be held June 14<sup>th</sup> from 9am to 4pm in Carthage. There will be presentations on various relevant topics. Stewart will be talking about our Adirondack Waterfest and other Districts will provide updates.

- XI. **Staff reports** Stewart disseminated and emailed copies of the staff reports. They are also appended to the minutes.
- XII. **District Conservationist's report** Bielli submitted the following: I have received applications/interest from three Hamilton County residents for high tunnels. I will be attending the water quality meeting on 6/5.
- XIII. New York State Soil and Water Conservation Committee report appended to minutes.
- XIV. **Correspondence** Katie received correspondence from Indian Lake Envirothon advisor Christine Kobo thanking us for an inspiring and meaningful experience for her students. We also received complimentary correspondence from Erik Reardon and Michelle Curry regarding the recent Water Quality Committee meeting.
