- **I.** Call to order with introductions Buyce called the meeting to order at 9:30 a.m.
- II. Pledge of Allegiance conducted.
- III. Roll Call conducted.
- **IV. Reading and approval of the April 4, 2023, meeting minutes** The minutes were provided in advance of the meeting.

Approving April 4th minutes was tabled as there was not a quorum present that attended that meeting.

V. Treasurer's Report – Remias reviewed the Treasurer's Report.

- A motion was made by Stortecky, seconded by Bain to accept the Treasurer's report, and approve the bills to be paid. All voted in favor, motion carried.
- **VI. Water Testing Program** Stewart reported that the Mohawk Valley Water Authority prices increased.
 - A motion made by Bain, seconded by Stortecky to set the 2023 Water Testing Program prices as follows: Total Coliform / E. coli qualitative \$30, Total Coliform / E. coli Quantitative \$45, Lead and Copper \$45, Water Chemistry Panel (alkalinity, total hardness, calcium hardness, fluoride, chloride, conductivity, sulfate, and turbidity) \$105. All in favor, motion carried.

VII. District Activities

- **a. Draft watershed health and farming justice legislation update** Stewart reported that she, Stortecky, and WhitKovits attended the Hamilton County Board of Supervisors meeting April 6, and the resolution opposing District Law amendments passed unanimously by those supervisors in attendance. Stortecky also attended and encouraged the supervisors to oppose the proposed district law changes. WhitKovits gave an update to the supervisors for the programs she is heading.
- **b.** Adirondack Tree and Shrub Sale Stewart reported that Croote, WhitKovits, and Remias have packed trees and will be assembling orders. Order Pickup is Saturday, May 6, 9 a.m. 12 p.m. at the Blue Mountain Fire Station (3454 NYS Route 28) and at the Brown Shed across from the Lake Pleasant Fire Hall (South Shore Rd).
- c. Lake Monitoring Program Stewart reported that she and Croote met with Adirondack Watershed Institute's Laboratory Director Elizabeth Yerger and Brendan Wiltse to discuss 2023 sampling analytes, including bottom water samples for lakes with confirmed harmful algal blooms. AWI will draw up the contract for laboratory services that will be reviewed at next month's board meeting. Stewart completed and submitted the Quality Assurance Project Plan to DEC for review.
- d. **Agricultural Environmental Management** WhitKovits reported that not much has happened since the last meeting.
- **f. Trail Stewardship Program** Stewart reported that she and Croote held an interview for the only applicant that applied, and hired Jacob Vander Pyl who begins May 22. Bill Farber assisted with coordinating trail training with the Adirondack Mountain Club. Stewart provided salary information to Rhodes for a DEC funding opportunity. Stewart has not heard

from any towns about projects for the seasonal technician.

g. Watershed partnership update

- 1. **FLLOWPA** Stewart attended the full board meeting on April 12. There has been change in personnel that we send reports to so there may be delays in getting our closeout approved.
- 2. **Upper Hudson River Watershed Coalition** Stewart hosted the April 13 meeting where the roadside erosion grant was reviewed.
- 3. **St. Lawrence River Watershed Project** Nothing new to report.
- 4. **Mohawk River Watershed Coalition** Stewart hosted the April 17 meeting. DEC is nearing the signing of the Action Agenda proposal for 1.5 million dollars.
- 5. **Black River Watershed** Stewart and WhitKovits presented stormwater pollution prevention with pervious pavers at Arrowhead Park, Inlet, during the Black River Adaptive Modeling Field Trip. They also reviewed the Lake Monitoring Program. Information will be provided to the consultants on tributaries and bathymetry.
- h. Hamilton County Envirothon WhitKovits reported that we have received \$900 in donations for the event, and we will be providing lunch for everyone for the first time. There are eight teams signed up to participate, although three teams chose not to compete as it is their first time attending. Brian Wells, County Chairman of the Board of Supervisors, is scheduled to give the opening remarks. There will be five stations where the students will be tested on their knowledge of soil, forestry, wildlife, aquatics, and climate change. Board members Stortecky and Buyce as well as Joyce and Tom Whitcomb have volunteered to assist with the event.
- i. **Arbor Day Poetry Contest** Stewart reported 22 senior citizens entered Japanese Lantern poems with the theme "Hope Grows Through Trees." Kathy Stewart will judge the poems, and the Arbor Day Awards Gala will be held at the Long Lake Public Library.

j. Conservation Education Program

1. Croote, WhitKovits and Stewart will present streambank stabilization through the lens of Warner Brook to Lake Pleasant Central School's 4th, 5th, and 6th graders. After learning about the project in the classroom, students will plant trees in the field. This presentation is in partnership with the Lake Pleasant Sacandaga Association, who sponsored half of the expense for tree planting bars.

k. Other

- Logo We had contracted with Adirondack Website Design to develop a new logo.
 Stewart presented the proposed new logo. Discussion ensued. It was decided not to use the new logo as the goal was simplification of colors and design and the proposed logo did not fit these criteria. As there was a set fee involved it was decided that we would pay the fee although we will not be using the logo.
- 2. Water Quality Coordinating Committee WhitKovits reported that a Water Quality Coordinating Committee meeting is scheduled for Monday June 5, at the Lake Pleasant Library from 9am to 12pm. There will be two speakers and hopefully there will be some meaningful discussions on what needs are and how to address them. Municipalities and lake associations have been invited. Anyone concerned with water quality is welcome and encouraged to attend. There are flyers posted throughout the county publicizing the event.
- 3. **Invasive Species Awareness Week** Is the week of June 5th. Stewart and WhitKovits have developed a mosaic contest to commemorate this week. The contest is open to all ages and any medium can be used. They are hoping it will be a fun way to get kids and adults involved and raise awareness of invasive species.
- 4. WhitKovits and Stewart attended the Adirondack Park Invasive Plant Program's spring meeting in Keene Valley. WhitKovits spoke with Terrestrial Coordinator Becca Bernacki about coordinating a knotweed stem injector program for Hamilton County landowners.
- 5. Lenny was unable to attend today because he is meeting with a landowner this morning. He's getting calls for hydroseeding, landowner assistance for sediment erosion control, and invasive plant inquiries are coming in. Lenny hopes to get a couple of stream projects on the ground this summer. With our FLLOWPA funds, he's working with the Town of Inlet, on a proposal to put in a rain garden to help soak up some more of their stormwater. We could hopefully take this county wide with Inlet being our pilot project for this green infrastructure.
- **IX. Staff reports** Stewart disseminated and emailed copies of the staff reports. They are also appended to the minutes.
- **X. District Conservationist's report** Tom Bielli reported that they have funded all the EQIP applications in Hamilton County. One being a high tunnel and pasture and the other a high tunnel. On the personnel side there will be a new Soil Conservationist starting in Ballston Spa at the end of July. There are also vacancy announcements for two more soil conservationists. Bielli also explained the Local Working Group and asked for interest or possible leadership. There will also be a second round of funding for the conservation stewardship program. Bielli also reviewed the Inflation Reduction Act.

New York State Soil & Water Conservation Committee Region 4 Report – May 2023

NYS SWCC News

SFY 2023-2024 Environmental Protection Fund: The Enacted SFY 2023-2024 Budget is now available at www.budget.ny.gov. In total, this year's approved EPF budget is yet another very strong showing of support for conservation programs. Overall appropriations for the FY 2023-2024 EPF were approved at level funding of \$400 million. Proposals of interest to SWCC/SWCDs in this budget include the following:

- \$19.5 million for Agricultural Nonpoint Source Pollution Control Projects, including \$2 million for Cornell IPM,
 - \$500,000 for the CCE of Suffolk County and \$250,000 for Cornell's Pesticide Management Program
- \$16 million for Soil and Water Conservation Districts (\$1.5 million increase over last year's levels)
- \$15.25 million for the Climate Resilient Farms Program, including \$500,000 to support Carbon Sequestration Projects and \$500,000 for the Cornell Soil Health Program
- \$22 million for Water Quality Improvement Program
- \$22.5 million for Oceans and Great Lakes (EBM Program funding)
- \$14.275 million for Waterfront Revitalization Program
- \$21 million for Farmland Protection

Climate Resilient Farming Program Round 7: \$15 million is available to support projects. The RFP and associated documents are now available on SharePoint,
