- I. **Call to order** Buyce called the meeting to order at 9:30 a.m.
- II. Pledge of Allegiance
- III. Roll Call conducted.
- IV. **Reading and approval of the October 17, 2023, meeting minutes** The minutes were provided in advance of the meeting.
- A motion was made by J.M. Stortecky, seconded by Buyce to approve the October 17, 2023, meeting minutes. All in favor, motion carried.
- **V. Treasurer's Report** Remias reviewed the Treasurer's Report and distributed October expenses for Board review and approval for payment.

- VII. Review and adopt the 2024 budget Stewart provided the 2024 proposed budget in advance of the meeting and reviewed it line by line. Discussion ensued.
 - A motion was made by J.M. Stortecky, seconded by Rhodes to adopt the 2024 Proposed Budget. All voted in favor, motion carried.

VIII. District Activities

- a. **NYACD Annual Meeting Review** J.M. Stortecky reported that he thought the meeting and training were very well put together. He believes everyone is trying to do the right things for conservation regardless of political affiliations. J.M. Stortecky was nominated and elected as the new Division Director for Division V which encompasses Hamilton, Franklin, Clinton Essex and Warren Counties. He will be travelling to these counties to meet with Board Directors and be acting as a liaison and is honored to serve in this position. Hamilton County received an award for District in News for our annual Poetry Contest.
- b. **Gilmantown Road Bank Stabilization Project** Stewart reported that the project is complete for 2023, and additional hydroseeding may occur in 2024. Lenny extends his thanks to the Hamilton County DPW for their partnership in this project.
- c. **July storm update** Stewart reported that Croote worked to extend permit authorization and hopes to complete essential projects before winter.
- d. Lake Monitoring Program Stewart reported that Adirondack Watershed Institute is completing lake sample analysis. Croote diligently worked since March to obtain required signatures from DEC for the Data Usability Assessment Report. Dr. Paul Bukaveckas of the University of Virginia used the District's lake monitoring data for research, and his paper, The effects of climate change and variability on thermal regime and dissolved oxygen resources of oligotrophic lakes in the Adirondack Mountain region, was recently published in the Springer

- *Nature* journal. Stewart showed the Board a video WhitKovits put together for them of the October Lake Monitoring.
- e. **Trail Stewardship Program** Stewart reported that she and Rhodes met with Department of Environmental Conservation staff to discuss the 2024 trail stewardship program. The District will not be signing a contract with The Department of Environmental Conservation for 2024.
- f. **Sediment and Erosion Control Program** Hydroseeding for the year is complete and the hydroseeder has been winterized.
- g. **Agricultural Environmental Management** Whitkovits submitted Round 18 Action Plan, and it was approved by the State Committee.
- h. **Invasive Species Program** Croote reported that he and WhitKovits treated Japanese knotweed with herbicide. Retreatment sites were on private and public land.
- Conservation Education Program WhitKovits and Stewart hosted a storytime and craft for the book Stellaluna at the Lake Pleasant Public Library for 15 kids and guardians. WhitKovits and Remias ranked the Conservation Field Day essay and poster contest entries. WhitKovits and Stewart presented Social Media and Websites at the CDEA Administrative Conference on November 6th to 20 District staff.
- j. **Watershed partnership update** Work continues.
- k. **Directors' comments** Director J.M. Stortecky reported that he met NRCS employee Dennis DeWeese at the NYACD annual meeting and showed him pictures of one of the high tunnels NRCS District Conservationist Tom Bielli facilitated in Hamilton County. J.M. Stortecky sees this as one of our successes that other Districts may want to pursue.
- **IX. Staff reports** Stewart disseminated and emailed copies of the staff reports. They are also appended to the minutes.
- X. District Conservationist's report Stewart reported that Bielli submitted the following: I won't be able to make it to your BOD meeting today. I'm meeting with Jim in Warren County this morning. I'll try to dial in at some point if I'm able. If I'm not able to break away, can you let the board know that we are offering EWP funding to the Town of Long Lake for the July storm to clean the debris out of Shaw Brook? Paula Bagley mentioned that Delaware County SWCD has assisted local municipalities there with EWP following previous storms. Just wondering if the Hamilton SWCD would be willing to entertain the idea of doing the same in this case.

NYS SWCC News

New NYS Grants Management System Coming: The SWCC wanted to make SWCDs aware that NYS is anticipated to launch a new integrated grants management system during the Month of January 2024. We expect to have more details on the transition to this new system in the coming weeks. The new system will effectively be replacing the grants gateway, and vendors (SWCD) that have registered in the old system to apply for grants will be rolled over to the new system automatically. At this time, we don't expect any changes in the application process for CRF or AGNPS. As we learn more about the new system, we will be sure to relay the information to SWCDs ASAP.

November SWCC Meeting: The next SWCC meeting is scheduled to convene at 10:00 AM on November 21st. Further details and an agenda for this meeting will be sent out shortly. Reminder – participation at a SWCC meeting is eligible toward PM1, Part C of State Aid to Districts.

2023 Part C Performance Measures: The end of the year is rapidly approaching, and you should be checking to make sure that your District is fulfilling its Performance Measure goals. Please contact your Regional AEA with any specific questions.

DEC Urban and Community Forestry Funding Available: NYSDEC is accepting applications for a total of \$12.9 million for urban and community forestry projects through the Inflation Reduction Act funding opportunity. Applicants may apply for funding under two categories, Community Forest Management Plan Implementation (\$10 million) and Ash Tree Management (\$2.9 million). The maximum request is \$500,000 per application and no match is required. All projects must take place in disadvantaged communities as identified by any of three Federal and State tools listed in the Request for Applications (RFA). The deadline to submit applications is Wednesday, Jan. 31, 2024. DEC's Urban and Community Forestry program is holding a virtual information session on Wednesday, Nov. 15th, from 10 a.m. to 12 p.m. to provide more information.
