VACANCY ANNOUNCEMENT – Seasonal Technician

DISTINGUISHING FEATURES OF THE CLASS

An employee in this class performs a variety of routine duties assisting the regular Soil and Water Conservation District ("District") staff in the execution of natural resources and conservation programs and / or projects. The Seasonal Technician will assist District staff in field surveys, developing of supporting documents and construction of conservation projects, and educational outreach events. Work is performed under the immediate supervision of the District Manager and other District staff. Does related work as required.

TYPICAL WORK ACTIVITIES (illustrative only):

- Assists with projects involving field work, including the use of Global Positioning Systems, Geographic Information Systems, and Survey123;
- Work may include the use of power equipment, planting, or physical labor;
- Assists with the District's Hydroseeding Program to stabilize eroding road banks and ditches, Lake Monitoring Program to collect water samples, Water Testing Program to oversee drop off and deliver samples to the lab, and Invasive Species Program to monitor and manage invaders;
- Provides technical assistance and written reports as needed;
- Helps to conduct conservation education programs;
- Assists the public with obtaining information from the District office;
- Other related duties as assigned by the District Manager.

- Comfort and experience spending time in a wilderness setting, regularly hiking long distances, and willingness to work in adverse weather conditions.

Graduation from high school or possession of a high school equivalency diploma and completion of thirty credits or more of college coursework in the field of natural resources, conservation, environmental science, agriculture, or closely related field.
